




This chart shows the total general purpose revenue Sierra Vista Charter High School expects to receive in the coming year from all sources.



# **Plan Summary [2023-24]**

#### **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

A dependent charter of the Tulare Joint Union High School District, Sierra Vista Charter High School (SVCHS) was originally Sierra Vista High School, and was developed in 1984 as an alternative for students who would otherwise be unable to attend school within a traditional setting. In 2014, the school converted to a charter high school. Our program is open to all students and offers both, a traditional independent study method of instruction, as well as online instruction options. An internal review of the independent study program and the need to provide additional options to enhance student opportunities and performance within the independent study program were the impetus for the development of a charter high school. The vision and purpose of Sierra Vista Charter High School is to provide a quality developmental program addressing the academic, career, and personal/social development of all students. Our program is a vital part of the mission of the Tulare Joint Union High School District which supports, facilitates, and maximizes personal and academic achievement for all students. SVCHS proactively assists students to acquire life-long learning skills, foster interpersonal communication skills, develop college and career readiness skills, and to be contributing members of society. SVCHS is part of the Tulare Joint Union High School District and is located in a unique community nestled within the heart of one of the most fertile agricultural regions in the San Joaquin Valley. The district encompasses a community of more than 78,000 residents who are passionate about the quality of life for our students during their school-age years and beyond. The district currently serves approximately 5,700 students. Sierra Vista Charter High School staff are committed to providing all students with a safe, nurturing educational environment that inspires students to reach their individual potential. Sierra Vista Charter High School is comprised of a diverse population of students in grades 9-12, and is comprised of 87% socio-economically disadvantaged, 8% students with disabilities and 12% English language learners (Source: 2020-21 CalPADS). Sierra Vista Charter High School is using the LCAP process to identify areas of needed improvement. The LCAP will highlight goals which focus on improving student achievement for all students, but more specifically students that are low income (LI), English-language learners (EL), and Foster youth (FY).

#### **Reflections: Successes**

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

SVCHS is seeing growth and improvement in graduation (90.1%) and attendance (91.95%) rates. Students passing with a C or better in Englilsh 90.8%, Math at 83.9%, Science at 88.7%, and Social Science improved to 90.3%. Suspension rates are minimal, with zero suspensions in 2021-2022.

#### **Reflections: Identified Need**

A description of any areas that need significant improvement based on a review of Dashboard and local data, including any areas of low performance and significant performance gaps among student groups on Dashboard indicators, and any steps taken to address those areas.

Based on the pilot Dashboard data and local performance indicators, our graduation rate is five and a half percentage points below the district average. This is a decrease of two and a half percentage points from the previous year. We will continue to support this area by providing one full time counselor and one part-time counselor who will develop individual academic plans for each of our students. Those students falling behind on credits will be offered response to intervention time and core class support. Also, based on the data, our greatest area of need is improving CAASPP-Math test results. Currently two percent of our students have met or exceeded the standards in the 2021-2022 school year. We will offer Algebra 1, Geometry, and Algebra 2 to better prepare our students for CAASPP. Teachers will be given opportunities for professional development and students will continue to receive extra academic support throughout the school year.

In this year's LCAP, we continued to focus on preparing all students to be college and career ready, increase the English Language acquisition of our English Learners and provide a safe and welcoming environment to all of our students. Based on stakeholder input, we changed our metrics in order to better identify our district's strengths and needs. One change we made was monitoring the percentage of students who are CTE Completers and who meet the College and Career Indicator. At SVCHS, our part-time ELD teacher will continue to provide support to our EL and redesignated students. To support a positive learning environment SVCHS continued to implement and improve the PBIS program and at the district level a Director of Student Services has been added to help support the safety and well being of students..

#### A summary of the feedback provided by specific educational partners.

The staeholders involved in the formalilzation of this year's LCAP included SVCHS staff, School Site Council, and Budget Advisory Committee. Areas to focus for the following year continue to be safety, PBIS, and student support.

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

SVCHS staff feel PBIS does a great job of supporting students but additional funding can better support college visitations and positive reinforcement through student incentive gift cards. Staff believe student recognition reinforces a positive learning environment and gives students a feeling of love and support to build positive connections with both the staff and the school. Teachers want students to have a connection to the school through academics, extracurricular activities, and social interaction. Safety is always a priority. The staff and committees feel SVCHS always does a great job with video and physical monitoring of the school. Full time security guards are provided throughout the school day. Friday RTI is a positive academic support intervention program that allows teachers to assign students mandatory instructional time if they have not completed work during the week, need additional academic support, or to retake tests.

Successful completion of core classes with a C or better, CAASPP performance, AP Test passage rates and CTE completer status will allow us to monitor our progress towards achieving this goal.

## Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

During the 20-21 school year, Edgenuity Courseware was implemented school wide to ensure that all courses that students take are A-G compliant. This will provide a greater opportunity for students to qualify as A-G Completers and qualify for entrance into four year universities directly out of high school. Implementation of the A-G courseware also has allowed for a standardization of student pacing throughout the year and a greater level of communication with student progress with parents and guardians. Sierra Vista continues to offer a foods pathway and will continue to expance its CTE Pathway to offer a variety of opportunities to be college and career ready. Sierra Vista will also be hiring an art teacher to provide more opportunities for students to complete both their A-G requirements and have an additional in-person CTE Pathway.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

We had material difference between Budgeted Expenditures and Estimated Actual Expenditures in the following areas:

- 1. Our expenditures for Edgenuity courses has increased from \$27,000.00 to \$329,230.00 there was a change in the way staff who implement and oversee Edgenuity courses are paid. This is created increase fidelity with the processes and procedures used to implement Edgenuity courseware. This created an overage for this action.
- 2. This year we were able to pay for CTE supplies using other funds. Next year we will be hiring a new Art teacher allowing us to use these funds with fidelity towards CTE programs.

An explanation of how effective the specific actions were in making progress toward the goal.

In this year's LCAP, we will continue to focus on preparing all students to be college and career ready, increase the English Language acquisition of our English Learners and continue to provide a safe and welcoming environment to all of our students. In using the Edgenuity program, we have been able to better monitor students progress in their core courses and has a variety of tools to communicate with parents the progress of their students. The use of this program has helped with an increase in the number of students with passing grades in their core classes. There was a drop in the math performance on the CAASPP test, however we have also changed the amount of tutorial support for math that students have access to.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Based on this data, graduation rates will hold steady, however our A-G rates are higher making our students college and career ready. We plan on continuing to support this area through providing professional development plan with a strategic tiered intervention plan. We will expand the amount of support to core courses and expand it to all courses that allow students to be A-G qualified and increase in the core course C passing rates. The data also shows that students have a need for greater CTE opportunities and the employment of an in-person art teacher will provide for this and should help increase our CTE qualifier percentage.

## Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

The actions included in goal 2 aim at supporting our English Learners in the acquisition of the English Language. This goal specifically ELD support and materials for students as well as provided professional development for staff. The support for students was in the form of a specific English Language Development Course built into the schools master schedule. This provided the needed support for ELL students on a one-on-one basis with and ELD credentialed teacher. Incentives were also provided to ELL students to try to encourage attendance to the ELD class.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There was a material difference between Budgeted Expenditures and Estimated Actual Expenditures due to the increase in the cost of staffing after changes to the salary schedule from contract negotiations. The overage costs to Goal 1 reflects these salary changes.

An explanation of how effective the specific actions were in making progress toward the goal.

There were increases in the passing rate for EL students in both English and Math and a decline in passing rates of students in science classes. There was a decline in the reclassification rates and the number of students scoring a 4 of the ELPAC test. There was no report on the graduation and drop out rates for EL students the year prior, however there was an increase from the baseline year.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

With the large decrease in the number of students not scoring a 4 on the ELPAC test we will focus on making sure EL students are attending their EL class. This year we had a larger number of EL students choosing to do their EL class over zoom, for next year we will not allow this option and students will need to attend their EL class in person. We will also incentivize the EL course attendance and promote it's worth for EL students. We will also maintain the staff of an EL teacher who will support the EL students in each of the subject areas. Additionally, an EL support lab will continue to be built into the master schedule.

Parent, student, and staff surveys indicate a need for a learning environment where students feel welcome and safe. All campuses are monitored using video surveillance, security guards, and a supervision team consisting of certificated staff, administrators, and counselors. Communication to students, parents, and guardians is a key ingredient for transparency. AERIES Communication allows administrators, counselors, and teachers to send out information through mass communications, direct messages, vociemail, text messages, or email specific to their site or individual students. The Positive Behavior Intervention and Supports program is an evidence-based three-tiered framework for improving and supporting all students to create the kind of school where all students are successful. Counselors are beneficial in supporting students academically, socially, and emotionally. They also provide encouragement so students feel valued and engaged as part of the schoolwide program.

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

The actions in Goal 3 supports our school site in creating a positive learning environment, where all students feel welcomed, safe, and engaged. This goal specifically includes providing services at our sites that support the well-being of our students. With the increase in our student population, we saw a need to increase the number of onsite counselors to 1.5. This helped support both our on campus students and those students choosing to stay distance learning. These counselors have provided academic emotional, and social support to the students. We have also provided incentives through our PBIS program to encourage students to exhibit our goals of S.T.R.O.N.G. (Safe, Trustworthy, Responsible, Organized, Never Give Up, and Goal Oriented). Another area of emphasis is maintaining communication with parents. this includes communicating over Parentsquare school activities, important dates, and parent advisory committees.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were material differences between Budgeted Expenditures and Estimated Actual Expenditures in the following areas:

- 1. The reported cost of counselors in last years LCAP was underfunded. The original budgeted amount was \$208.74, however the actual cost was \$184,990.00.
- 2. We had a reduction in the amount of cost for Parent and Family Engagement due to changes in the amount of Electronic Communication that was used. The budgeted amount was \$3,200.00 and the actual cost was \$0.00.
- 3. We had a reduction in the amount of funds needed for security cameras. The budgeted amount was \$1,500.00 and the actual cost was \$150.00

An explanation of how effective the specific actions were in making progress toward the goal.

The increase in counseling services to students has had an effect on our passing rates in core courses. They have also provided social emotional support to the students. We have had an increase in our attendance rate going from an attendance rate of 88% to 89% which is 2% above our baseline rate. Our suspension numbers continue to be at 0%, which is .8% below our baseline number.

TJUHSD demographics indicate that 75% of our students qualify for Free & Reduced meals, 11% are English Learners, and 1% are Foster Youth. Because these groups represent a significant percentage of our population, our stakeholders have determined that all district goals are designed to close the achievement gap, provide additional learning opportunities, and meet the needs of our targeted students. The district's unduplicated eligible students comprise 73% of our student population. In preparation for the 2021-2022 LCAP, we used our Budget Advisory, cabinet and other stakeholder meetings to analyze a variety of quantitative and qualitative data and determine the needs of our Low Income (LI), English Language Learners (ELL), and Foster Youth (FY). The academic progress of these student groups, as evidenced by their performance in class and on state assessments, validates the need for ongoing academic support, as well as professional development and time for our teachers to plan for the learning needs of our unduplicated students. During the past three years, our CAASPP results in English show an increase of 21% to 49% and 0 to 14% in Mathematics.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

Sierra Vista Charter High School will increase or improve services by utilizing the district Child Welfare and Attendance Officer, core support, and counseling services to help English Learners, foster youth, and low-income students. Additionally, the services listed below are principally directed at our unduplicated pupils.

- ELD coaches
- Staff development on embedding ELD standards and instructional strategies in Social Studies, Mathematics, and Science are both services provided specifically for English Learners
- Continue to profide credit recovery courses for students at-risk of not graduating through summer school, winter intercession and before and after school (LEA-wide).

However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])

  - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting
    the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).
